Call to Order

As no other nominations were made, Chair Kirby closed nominations. A vote was taken, and all present voted in favor of the nominee, GeMonee Brown. Chair Ford then appointed Bill Patrick to serve on the Complaints Review Committee.

Approval of the January 28, 2024, Meeting Minutes

Member Johnson moved to approve the January 28, 2024, board meeting minutes. Member Kirby seconded the motion. All in favor, the motion carried.



KREA Update

Deputy Executive Director Carlin congratulated Members Ford, Brown, and Patrick on their appointments and provided the Board a brief update regarding the vacant staff positions within the Kentucky Real Estate Authority.

Legal Update

Staff Attorney Rogers congratulated Chair Ford, Vice Chair Brown, and Member Patrick on their appointments on the Board. She reserved her legal advice for closed session.

New Business/Old Business/Miscellaneous Matters

• **Proctored exams through KCTCS**: Procedural Development Specialist Seth Branson reported that since the last update on December 13, 2023, nine (9) people have taken the exam. Of those nine (9) individuals, three (3) passed and six (6) failed the exam. Member Johnson motioned to have the Chair appoint a small committee or person(s) to examine the study guide and exam to look for ways to improve the study guide. Kirby seconded. Having all in favor, the motion passed. Chair Ford appointed Member Kirby to review the study guide.
