Call to Order:

• Board Chair Kirby called a meeting of the Kentucky Board of Auctioneers to order at 9:03 a.m. EST Members Kirby, Johnson, Ford, Patrick, and Brown were present, and a quorum was established.

Approval of the December 2023 Meeting Minutes:

• Member Johnson moved to approve the December 13, 2023, board meeting minutes as presented. Member Patrick seconded the motion. All in favor, the motion carried.

Kentucky Real Estate Authority Update:

 Deputy Director Carlin informed the board that the Kentucky Real Estate Authority hired a new employee, Holly Houillion, as the new Administrative Specialist III. Her main job duties will be assisting with the licensing staff with KREC & will be also fill in for any of the other 3 boards in the absence of the board coordinator to establish continuity in the administrative process.

Legal Counsel Update:

Staff Attorney, René Rogers, reported that she has been working with the investigator on several
cases that are under investigation for the Board of Auctioneers. Commissioner Johnson requested
an update biennial renewal regulation. René Rogers informed the board that previous General
Counsel, August Pozgay, resigned his position.

New Business/Old Business. Miscellaneous Matters

• Online Proctored Exam Update for 2023:

Procedures Development Specialist, Seth Branson reported that 100 examinees had taken exams in 2023 compared to the 93 that took an exam in 2022.

Total New Licenses issued in 2023:

Administrative Coordinator, Pam Samples, reported that 93 new licensees had received their licenses in 2023. This was up from just 87 new licensees in 2022.

Active Licensees as of January 26, 2024:

Procedures Development Specialist, Seth Branson reported that as of January 26, 2024, we have a total of 1,575 active licensees. Principal licensees - 1,238; Apprentice licensees - 274; Auction House Operators - 50; and Limited Livestock licensees - 13.
