## Call to Order and Roll Call

Chairperson Ford called the meeting of the Kentucky Board of Auctioneers to order at 9:50 a.m. ET. Members Ford, Johnson, Brown, Patrick and Kirby were present, establishing a quorum.

## **Approval of Minutes**

Member Johnson moved to approve the May 14, 2025 meeting minutes as presented. Member Patrick seconded the motion. Having all in favor, the motion carried.

## **Division of Real Property Boards Update**

Executive Director Tracy Carroll wished a Happy Father's Day to everyone that was in attendance & gave an update with the potential change in board members. The process has advanced to the Governor's office of Boards & Commissions. Director Carroll introduced Sahil Rachan with the University of Kentucky and Calee Carroll with Western Kentucky University as the summer interns that will be working with all four real property boards this summer.

Deputy Executive Director Gerald Florence stated that this was the highest number of interns KREA had since 2017. Deputy Director Florence advised the Board there is a vacant seasonal position that the Authority is looking to fill by July 16, 2025. There is also a new vacant position that will complement all three Real Property Boards and that Leadership is looking to fill the vacancy soon.

## Financial Update

Deputy Director Gerald Florence presented the Budget total for the Board of Auctioneers as \$639, 755.25 FY25 YTD on 06/02/2025.

The total for the Board of Auctioneers Education and Recovery Fund was reported to be \$667, 779.85 FY25 YTD on 06/02/2025.

#### Division of Real Property Boards Legal Update

General Counsel, Patrick Riley advised the Board that staff will be shifting to updating the Kentucky Board of Auctioneer regulations once the Kentucky Real Estate Appraisers Board regulations have been submitted to the Legislative Research Commission. Counsel Riley also wished everyone a Happy Father's Day and reserved all other comments for closed session.

Administrative Coordinator Scott Pieratt reported that six (6) persons took the Auctioneers examination. Of that total number of people taking the examination, two (2) failed and four (4) passed the examination.
