PRINCIPAL AUCTIONEER EXAM APPLICANTS

If you are a licensed Apprentice Auctioneer applying to take the Principal Auctioneer exam you must attach proof of your completion of the eighty (80) hours of approved classroom instruction to this application.

If: (1) you are applying to take the Principal Auctioneer Exam; (2) you live out of state; and (3) you are requesting that the Apprentice Exam be waived based upon your experience, then you must attach a letter addressed to the Board making the request and detailing the experience you have that entitles you to this privilege. **The Board will consider your request at the regular meeting following its receipt of this application.**

If you are currently a licensed Apprentice Auctioneer, and you are applying to take the Principal Auctioneer exam, you must print page three (3) of the Auctioneer License Application, Schedule B, Certification of Principal Auctioneer, have your current Principal Auctioneer complete it, and submit it with this application.
